

Conditions of participation for sweepstakes of the EBERL Chiemsee Triathlon

By participating in the sweepstakes on the Instagram/Facebook account of the "EBERL Chiemsee Triathlon", its website and via other channels of the EBERL Chiemsee Triathlon, the user accepts these conditions of participation.

The sweepstake is organized by "Wechselszene Sven Hindl GmbH" (limited liability), Mühlhausen 3 1 / 2, 92280 Kastl.

- The opportunity to participate in the campaign mentioned ends at 11:59 p.m. on the day announced in the sweepstake post.

- Only one entry per post is possible per person.

Persons who meet the criteria specified in the relevant sweepstake and who have reached the age of 18 are eligible to participate.

- Employees of "Wechselszene Sven Hindl GmbH" and their relatives are excluded from participating in the sweepstake.

- Persons who have fulfilled all the conditions listed in the sweepstake post are eligible to win.

- The winners will be drawn from all participants and notified of their prize by direct message on Instagram, Facebook or by email (if participation in the sweepstake is also possible by email).

- As proof of the actual distribution of prizes, the winner's name may be published in anonymous form (e.g. in a separate post under "Paul M. from Frankfurt").
